The "Casa do Bom Menino Piracicaba" was founded in 27/11/1962 and supports babies, children and youth aged between 0 and 18 years old who are under social and economical vulnerability. It is a foster house/shelter that supports people who had their rights infringed.

It receives children and youth that are away of their family because of personal or judicial reasons such as domestic violence, drug's using and non-acceptance of the individual.

The actual system in the big cities in Brazil has a political-economical method in favor of a minority (the rich and millionaire people). As a consequence, social inequality is clear.

The children and youth's family, most of times, do not have access to social basic rights which was set in the Brazilian Federal Constitution of 1988 as work, health, sanitation, education and house for the citizens.

Therefore, the entity provides to them a place to sleep, hygiene, clothes, food, education through projects etc.

We work for family approaching, education to the community/world system, professional and emotional improvement, stigma empowerment, capacity building and peace building.

A large number of peace building project have being undertaken. Although we work up to overcome different kind of conflicts, without peace building work, the other aspects will be very difficult overcome. Therefore, it is possible and reasonable to mention that peace building work is the main activity or target in our organization.

Piracicaba city has around 297.767 inhabitants. The entity affects significantly the "Nova America" suburbe and other areas. The children and youth can walk around the city. However, they need to ask for permission and let the educators get to know where they go.

During the peace building work we had a lot of positive impacts such as approach to their family, part-time job, professional skill building.

We, as educators, also learn with them. Their life story and experience, behaviour and interaction with us teach us a lot. It is a exchange of views, perspectives, emotions and human behaviour.

The project "Planting and Learning" from the entity aims to provide education through pedagogical playful activities and through the idea to build up a food garden and a pleasant atmosphere for all member of the shelter. It raises environmental awareness in children and youth through hands-on experiences in the field.

The concept of urban agriculture was established in the project. The goal is to instigate the environmental importance and the possibility to have a food garden or sustainable food production in the houses back yard.

Furthermore, it can be an own source of money whether the products of the food garden are sold and an organic and healthy food be produced. Developing a food garden has a less negative

impact on the environment in comparison to the traditional way of food production, which has several chemical fertilizers.

Activities and interventions about diverse concepts and practices are part of the project, including essential topics, such as energy, food security, water availability and water saving. Some of the developed activities include reducing, reusing and recycling of "waste".

The project is within one of the organization goals, an educational atmosphere that can promote social, group and individual development among the children and youth.

# A story of success

Some people of the local community get involved through volunteering activities and with donation.

The local community got very surprised with the interaction of children and youth from the foster house "Casa do Bom Menino Piracicaba". There was a day in which the children and youth walked around the local community offering lettuce and other vegetables (own production) among the neighborhood.

That was a very important moment because it demystifies the view that children and youth from the foster house are not polite or even dangerous and bad. The idea is to keep running the project with more success among the local community changing people's life and providing a perspective of life, knowledge and inspiration.

The entity has organized some events in order to approach family to the children and youth. It was possible, in some moments, to realize and feel a peaceful atmosphere in these opportunities. During this year, we could see families that tried to overcome their challenges and so tried to approach to their children, to offer care and protection.

Therefore, the peace building is a crucial element in our job and mission.

The community was used to see the foster house/shelter as a place to avoid. Nowadays, the community members, sometimes, join the activities of the food garden and even the events. The prejudice towards the children and adolescents from the "Casa do Bom Menino" has decreased significantly.

The "Casa do Bom Menino" is a philanthropic entity that depends on donations such as food, clothes, toys, hygiene materials etc. The social projects are supported by FUMDECA (Funding Resource for Children and Adolescent). Citizens and other entities can also forward the products/public taxes fee to the "Casa do Bom Menino".

The area of the entity consists of 1100 m2. Before the implementation and start of the project idea, the area was used to deposit construction residues such as bricks and iron structure. The area was not used for any educational propose.

The "Casa do Bom Menino" has done a partnership with a landscape office. The idea is to insert the sustainable food production system (food garden) in pleasant atmosphere.

However, the "Casa do Bom Menino" do have enough fund to develop the landscape project in the sustainable food production project. It is necessary to purchase several materials, structures and items in order to set it up.

It is aimed to transform the area into a place for better educational atmosphere as well as a place for the relatives try to approach to the children and youth through plantations, and fruit and vegetables harvesting, for instance. Therefore, a landscape project would be significant to achieve that and build up a family approaching and so to develop peace building as well.

The space redesign will be fundamental for the purpose of re-signification or a new concept of the foster house/shelter as healthy place full of nature and peace, in which the children and youth will be able to dedicate to the food garden activities for the environmental education and a healthy food (organic).

The landscape project is planed since the last year but we did not find sponsorship or funding resource for its implementation. We believe that with a more pleasant atmosphere and more beautiful place the caring towards the area will be much more effective. In light of this, the foster house/shelter will be a better place for peace building among children and youth who are socially and economically vulnerable.

Innovation: It is the first time there is an environmental project in the entity. Before, the area where we are developing the market garden was a sort of waste deposit. There was a lot of weed, bricks, plastic bags and garbage.

Now, the place is getting much more beautiful and pleasant in a way that environmental education can be approached and developed. Nevertheless, we are trying to find a sponsorship for a landscape project which is fundamental for the whole context of environmental and social education.
