# INTERDEPENDENCE THEORY AND THE MEASUREMENT OF INTERNATIONAL CONFLICT (JON PEVEHOUSE)

#### Abstract

Discussions of trade interdependence and its political implications occasionally discuss the operationalization of interdependence in some detail, yet the measurement of the dependent variable—international conflict—has largely been taken for granted. Because of this absence, current studies ignore the possibility that realist and liberal interpretations of the political ramifications of interdependence could both be correct. Moreover, current measures of interstate relations allow only a partial testing of interdependence theory. I argue that events data can provide a better measurement of conflict and cooperation in testing theories of interdependence. I highlight the key theoretical claims in this debate, arguing that their predictions are not necessarily mutually exclusive. Finally, I undertake an analysis of interstate political cooperation and conflict which shows that trade has little bearing on levels of cooperation and that increased trade dependence can spur conflict, yet keep these conflicts from become endemic between trade partners.

"Given the commonly accepted measurement of international conflict in current studies, much of the nuance of interdependence theory has been discarded. By oversimplifying the measurement of political interactions, current studies ignore the possibility that realist and liberal interpretations of the political ramifications of interdependence could both be correct. Moreover, current measures of interstate relations allow the testing of only part of interdependence theory."

"In sum, liberal and realist camps make strong predictions about the impact of trade on conflict and cooperation. Liberals proffer that through multiple causal processes, trade provides disincentives to fight, as well as positive induce- ments to cooperate. For some realists, trade can provide opportunities and motivation for states to engage in conflict, rendering relations between states more hostile. Other realists predict no systematic relationship between trade and conflict, with other political and military factors overwhelming any influence of commerce.

One crucial issue rarely discussed in this literature, however, is the nature of these competing claims. For instance, there is no logical reason why trade cannot simultaneously increase conflict and cooperation."

"Although the results presented here are certainly not the final answer to the question of trade's influence on political relations, the evidence does suggest that a complex relationship exists between these two concepts. These complexities are suggested by the finding that trade may both increase the probability of conflict, yet restrain the frequency of that conflict. This observation is consistent with both realist and liberal theories concerning the political effects of interdependence."
